



# **CLEARANCES**

These models are suitable for use both indoors and outdoors.

WARNING: Ensure that your fire is positioned away from flammable materials and other sources of ignition at all times. Pay very close attention to positioning the fire away from items that may move as a result of wind and drafts. For example trees/branches/curtains/ paper and the like.

#### Aspect, Citi, Cube, Cube Jr, Oxygen, Zeta

There are no additional requirements for side and/or overhead clearances.

#### Igloo, Ghost

There must be a minimum of 1500mm [59in] between the mouth of the flame and the nearest combustible at all times.

#### Vision, Fusion

Both Vision and Fusion models are designed as a room divider but can also be placed against any flat wall surface made out of noncombustible material, or sitting 100mm [3.95in] away from any wall of any material. Always place the glass side closest to the wall. Even when unit is used as a room divider, the glass side is the "rear."


#### Tower, Q, Retro

Side clearances to fixed and stable furniture items that are not susceptible to movement such as lounges or patio furniture must remain a minumum of 600mm [23.6in] away from the flame at all times.


Overhead clearances to items that are susceptible to movement (e.g. Curtains/Trees) must remain a minimum of:

- Indoors: 1500mm [59.1in] away from the flame at all times.
- Outdoors: 2000mm [78.7in] away from the flame at all times.

When not in use it is recommended that you protect the model from water damage or corrosion by covering. Burner covers are available.
